Following this transaction, the Fund's total issued share capital is 124,682,250 redeemable participating preference shares, of which 17,895,000 shares are held in treasury. Accordingly, the number of shares with voting rights in issue is 106,787,250. This figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
