## Middlefield Canadian Income GBP PC - a cell of Middlefield Canadian Income PCC

## **Purchase of Redeemable Participating Preference Shares into Treasury**

Middlefield Canadian Income PCC (the "Company") announces that it has today purchased for cash 50,000 redeemable participating preference shares each of no par value in Middlefield Canadian Income – GBP PC (the "Fund"), a cell of the Company. The shares were purchased at a price per share of 98.75 pence. The Shares will be held in treasury.

## **Voting Rights and Capital**

Following this transaction, the Fund's total issued share capital is expected to consist of 124,682,250 redeemable participating preference shares, of which 16,700,000 shares are held in treasury. Accordingly, the number of shares with voting rights in issue is 107,982,250. This figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FSA's Disclosure and Transparency Rules.
