#### CRA Form T5 – Statement of Investment Income

This form will be printed and mailed by Middlefield<sup>®</sup> to clients. It reports the dividends paid by Middlefield Mutual Funds Limited for the 2018 taxation year. The anticipated mailing date is February 28, 2019.

# CRA Form T3 – Statement of Trust Income Allocations and Designations

This form will be printed and mailed by Middlefield<sup>®</sup> to clients. It reports the distributions paid by Middlefield Global Infrastructure Fund for the 2018 taxation year. The anticipated mailing date is April 1, 2019.

All non-resident holders of the Mutual Funds will receive "CRA Form NR4 – Statement of Amounts Paid or Credited to Non-Residents of Canada" instead of a T5 or T3. The anticipated mailing date for the NR4 is April 1, 2019.

## CRA Form T5008 - Statement of Securities Transactions

This form will be printed and mailed by Middlefield<sup>®</sup> as appropriate to clients. It reports the redemption of mutual fund securities by providing the proceeds and adjusted cost base of securities that have been disposed of during the 2018 taxation year. Investment Dealers may, in addition, issue a "transaction summary" to their mutual fund investors that will report redemption proceeds. To avoid confusion for Canada Revenue Agency ("CRA") and investors, Middlefield<sup>®</sup> will disclose on the T5008 the reporting overlap to ensure the proceeds amounts are not counted twice. The anticipated mailing date is February 28, 2019.

#### CRA Form T5013 – Statement of Partnership Income Rélevé 15 – Amounts Allocated to the Members of a Partnership (Quebec filers only)

These forms will be printed and mailed by Investment Dealers to clients based upon tax information that Middlefield will supply electronically for our resource partnerships. These forms report the various types of income and deductions of the partnerships. Middlefield will provide the tax information by March 7, 2019 once the partnership receives the required tax information from the resource companies in which investments were made during 2018. The mailing deadline for Investment Dealers is April 1, 2019.

The Tax Guide contains the Federal tax forms and other information that will assist clients when preparing their 2018 income tax returns. This form will be printed and mailed by Investment Dealers to clients based upon tax information that Middlefield<sup>®</sup> will supply electronically for our closed-end funds. Middlefield<sup>®</sup> will provide the tax information by March 7, 2019 once the Funds receive the required tax information from the entities in which the Funds were invested during 2018. Middlefield<sup>®</sup> will also post the taxable nature of distributions on its website. The mailing deadline for Investment Dealers is April 1, 2019.

## CRA Form T5008 – Statement of Securities Transactions

Investment Dealers will print and mail either this form or a "transaction summary", to their clients, to report redemption proceeds. The mailing deadline for Investment Dealers is February 28, 2019.

## CRA Form T5 – Statement of Investment Income

This form reports the dividends paid by Global Real Estate Dividend Corp., Globalance Dividend Growers Corp., E Split Corp., and MBN Corporation (collectively, the "Corporate Funds") to their shareholders during the 2018 taxation year. It will be printed and mailed by Investment Dealers to clients based upon tax information that Middlefield will supply electronically for the Corporate Funds by early-February 2019. The mailing deadline for Investment Dealers is February 28, 2019.
