NOTE TO LIMITED PARTNERS:

After the dissolution of MRF 2021 Resource Limited Partnership – Class A Units (the "Partnership"), Limited Partners are entitled to deduct their pro-rata share of the undeducted issue costs of the Partnership on the same basis as such expenses would have been deducted by the Partnership were it not dissolved.
