Global Dividend issued a special distribution of \$1.10 per Unit on December 30, 2024. The special distribution was paid in additional Units of Global Dividend; however, immediately after the issuance of additional Units the outstanding Units of Global Dividend were consolidated such that the number of Units outstanding remained unchanged from the number held immediately prior to the distribution.

The return of capital component of the distribution is not taxable; however, it reduces the adjusted cost base of the Units.

Global Dividend Units trade on the Toronto Stock Exchange under the symbol MDIV.
